EXHIBIT A to JEFFERSON LANDING DECLARATION OF TRUST RULES AND REGULATIONS 28.

Owner -Occupied Requirement All Units of the Condominium shall be owner-occupied as required in the Special Permit granted by the Marlborough City Council Order No 18-1007245C dated October 15, 2018, recorded with the Middlesex South Registry of Deeds in Book 72034 page 96. In the event that this requirement is violated by a Unit Owner (excluding 27 Jefferson LLC, who is the applicant of the Special Permit aforementioned), a financial penalty not to exceed \$100.00 per day shall be assessed upon the Unit Owner by either the City of Marlborough or the Trustees, who for purposes of this requirement shall annually furnish the City's Building Department with a list of names of the individuals then occupying each Unit. Notwithstanding anything to the contrary in the Master Deed, Trust or By-Laws, this paragraph 28 (Owner - Occupied Requirement) shall not be amended.
